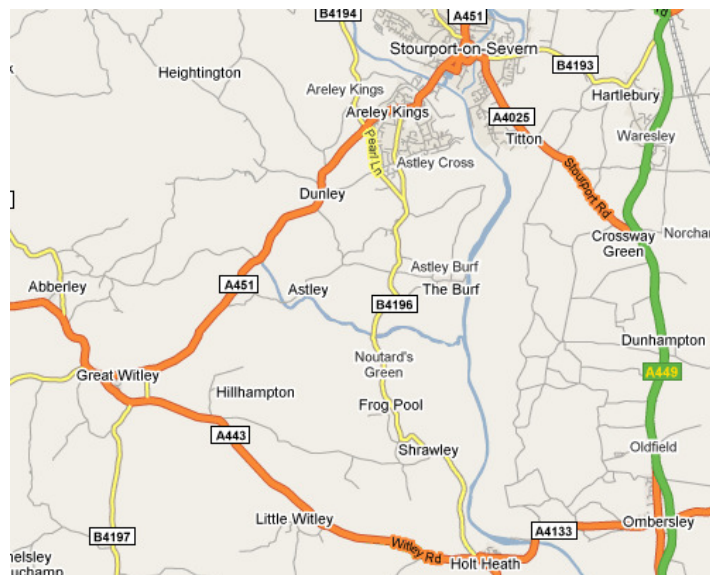
SAFETY

COURSE

Race will be neutralised from village hall to start/finish line.

- 1) Start/finish area on B4196 (Pearle lane), 200 metres before A451 junction.
- 2) Left onto A451 (M) towards Witley direction to half a mile before Hundred House PH, Great Witley.
- 3) Left onto feeder road (M) leading to 4) Left onto A 443 (M) towards Holt direction to Holt Heath.
- 5) Left onto B4196 (M) towards Stourport direction to Astley to complete lap.
